15K RACE COURSE

The start location is at Norwood's Seafood Restaurant, Southg Causway Beachside, in New Smyrna Beach.

The ChampionChip scored, and certified 15K out-and-back course follows quaint residential roads northward to the Dunes Park, loops around the surfside boardwalk and returns to Norwood's.

30K RACE COURSE

The ChampionChip scored, and certified 30K course, follows S. Atlantic Ave, and then loops northward through shaded neighborhoods along Saxon Ave. From the halfway point at Norwood's, the course continues along the same route as the 15K, to Dunes Park, and returns to Norwood's for the 30K finish.
